## CCR Highlight - Article IV Section 4.09 - Lot Maintenance

Owners shall keep all weeds, grass, and landscaping located on their lots in a sanitary and attractive manner. All homeowners are asked to take pride in their properties and our neighborhood by keeping up their yards and gardens. This is a beautiful neighborhood when lawns are cut and the colors flow out from our gardens. While we are in the dead of winter at this time, spring is just around the corner. Owners shall not permit the accumulation of trash or rubbish of any kind on their lot. All are asked to address such things as inoperable vehicles, construction materials, and other unsightly objects as well as properly storing such things as garbage receptacles that may clutter properties.

## **Street Lights**

Street lights that have burned out should be reported directly to Entergy. The phone number has been added below and will become a permanent fixture in the newsletter. Entergy is responsible for swapping bulbs. If the actual light fixture is the problem, as was the case recently in an area of our neighborhood, then Entergy advises the parish who then issues a work order. We would like to acknowledge Councilwoman Cheryl Millet for her assistance in expediting the repair of the lot fixture prior to Halloween so that children were not trick-or-treating on a very dark street.

The Board will soon accept bids for the grass cutting contract. Anyone who is interested in soliciting more information about the bid process may contact a Board member. There are specified areas of the subdivision that are to be cut. The contracted period is 2/1/09 - 1/31/10.

## -ARCHITECTURAL REVIEW REQUIREMENTS

Please submit all plans for new construction or improvements to the Architectural Control Committee in care of:

For your convenience you can also submit this to any board member and we will see that it gets to Mr. Brazil

Also, please note that you have an obligation to St. John the Baptist Parish to obtain a building permit for any new construction or improvements to your existing property. For more information concerning the parish ordinances you can call (985) 652-9569.

New construction plans should include:

House elevations showing front, rear & both sides of the structure. The elevations should show exterior wall materials, roof pitch from all angles & slab elevation in relation to street.

Floor plans with living area & under roof area calculated on plans.

Site plan showing lot dimensions, location & width of driveways & sidewalks, setback distances from the lot lines for the house, garage, patio, drive, sidewalk & any other ground improvements.

Name, address, lot number & phone number of homeowner & the builder (if different).

There is a \$200.00 architectural committee fee for new homes.

Existing homes must submit prior to construction:

- Location of improvements drawn on a site plan showing lot line setbacks.
- Materials to be used.
- Fences materials, height & type.
- Bulkheads materials, height &
- Additions plans showing elevations, roof pitch & exterior wall materials.
- Above-Ground Improvements exceeding 3' height - precise dimensions & location on lot
- Swimming Pools type of pool & fencing.
- Name, address, lot number & phone number of homeowner.
- Any fee incurred will be passed on to the homeowner.
